The Faculty of Administration and Management, King Mongkut's Institute of Technology Ladkrabang, is calling for applicants to its 2019 undergraduate international program. Candidate selection in this Direct Admission (Extra Round) is based on the following criteria.

**1. Programs of study and Number of admitted students**

The Faculty of Administration and Management accepts applications for admission for the Academic Year 2019 for the following undergraduate program:

- Bachelor of Business Administration (International Program)

The number of admitted students in the Direct Admission (Extra Round) is **10** students.

**2. Applicant qualifications**

Applicants for the Direct Admission (Extra Round) are required to meet the following requirements.

**Applicant is studying or obtained a high school (Matthayom 6) diploma from a high school in Thailand or overseas in equivalent.**

Applicant must satisfy one of the following requirements;

2.1) Applicant has obtained or expected to obtain prior to the start of Academic Year 2019 a qualification equivalent to a high school diploma taught in English. Applicant's GPAX will not be considered as the main criteria for admission.

2.2) Applicant has obtained or expected to obtain prior to the start of Academic Year 2019 a qualification equivalent to a high school diploma taught in Thai/or other languages need to have

a) Experience as an exchange student in a country where English is an official language

b) Or Experience in a multicultural environment such as a cultural exchange program, an English competition, a family business with international trades, an experience of living overseas, public speaking in English or any other remarkable performance.

**Remark:** If the applicant interested does not meet the criteria contained in either a) or b), the applicant can still apply to this round. However, the applicant will be considered by the interview committee whether the applicant is qualified to study.

### **Other qualifications**

The interview committee will consider applicants who provide evidence of English proficiency and/or mathematics test scores as a plus.

**\*\* Please note applicant must satisfy one of the requirement qualifications above and present it to the committee at the interview. \*\***

### **Essential qualifications**

1. Applicant must be under the Domestic form of Government with the King as the Head of the State.
2. Applicant shall be physically and mentally healthy.
3. Applicant must demonstrate good behavior and good attitudes toward their studies and strictly conform to the Institute's rules and regulations.
4. Applicant should not have been expelled from any other institute because of improper behavior.
5. Applicant must be authorized to stay in Thailand legally.
6. Applicant should not have been punished in accordance with corruption in any exam.
7. Applicant should not have been dismissed from any institute because of liabilities.

#### **6. Announcement of the admission**

The Faculty of Administration and Management, King Mongkut's Institute of Technology Ladkrabang, holds the right to select the eligible applicants. The accepted students name list will be announced by the institute's Office of the Registrar at <http://www.reg.kmitl.ac.th>. on the 19 July 2019.

#### **7. Confirmation of the student status and tuition fee payment**

The applicant, who is accepted for enrollment, shall confirm their desire to be a student via <http://www.reg.kmitl.ac.th> and making the confirmation payment during 23 - 24 July 2019. Non-confirmation and/or any avoidance of any process may result in disqualification. Any payments, application fee and/or confirmation payment, made by the applicants are non-refundable.

#### **8. Disqualification**


8.1) The accepted applicant who does not confirm the enrollment (online) and does not make the payment within the specified time will be considered disqualified.

8.2) The accepted applicant who have not obtained a high school diploma prior to the start of Academic Year 2019 will be considered disqualified.

**9. Tuition fee**

The qualified applicant, who is accepted to be a student of Faculty of Administration and Management, must make a payment 40,000 Baht per semester for tuition. Please note that the application payment is non-refundable.
