The KMITL Business School, King Mongkut's Institute of Technology Ladkrabang, is calling for applicants to its 2020 International Undergraduate Program. Candidate selection in this round is based on the following criteria.

1. Programs of study and Number of admitted students

The KMITL Business School accepts applications for admission to the Academic Year 2020 in the following undergraduate program:

- Bachelor of Business Administration in Global Entrepreneurship (International Program). All teaching and learning activities and materials in the program are conducted in English.

The number of admitted students in this round is **50** Thai students.

2. Applicant qualifications

Applicants for this round are required to meet the following requirements:

Graduated from or studying in the final year of school, grade 12 (US system), grade 13 (British system) or Matthayom 6 (Thai system), or equivalent at an accredited college or educational institution in Thailand or abroad.

The applicant must satisfy one of the following requirements.

2.1 The applicant has obtained or is expected to obtain prior to the start of Academic Year 2020, a qualification equivalent to a high school diploma. The applicant's GPAX will not be considered as the main criterion for admission.

Other qualifications that are preferable:

2.2 The interview committee will consider applicants who provide evidence of English proficiency and/or mathematics *test scores* as a plus.

If the prospective student is a non-native English speaker or does not hold an international high school diploma (English Program), he/she should obtain a test result from one of the following tests: Test of English as a Foreign Language (TOEFL ITP), International English Language Testing System (IELTS), or the College English Test (CET).

2.3 Personal Statement: Students should provide their personal statements in English, answering the question: “Why do you want to join BBA in Global Entrepreneurship?” (not more than 1-2 pages, please submit along with the application).

2.4 Having a strong ambition to be an entrepreneur by reflecting it in the personal statement or having a family background in entrepreneurship by showing evidence that his/her family possesses a business.

2.5 Having experience as an exchange student in a country where English is an official language, having experience in a multicultural environment such as a cultural exchange program, an English competition, a family business with international trades, experience from living overseas, public speaking in English or any other remarkable performance.

** Please note that the applicant must satisfy one of the requirements above and present it to the committee at the interview. The interview committee will consider whether the applicant is qualified to study. **

Essential qualifications

1. Applicants shall be physically and mentally healthy.
2. Applicants must demonstrate good behavior and good attitudes toward their studies and strictly conform to the institute’s rules and regulations.
3. Applicants should not have been expelled from any other institute because of improper behavior.
4. Applicants must be authorized to stay in Thailand legally.
5. Applicants should not have been punished for corruption in any exam.
6. Applicants should not have been dismissed from any institute because of liabilities.

8. Disqualification


8.1) Accepted applicants who do not confirm the enrollment (online) and do not make the payment within the specified time will be considered disqualified.
